12 **COSTS TO ESTABLISH A BUDGET TO MAKE CERTAIN WATER AND**
13 **STREET IMPROVEMENTS TO SUNSET DRIVE, 40TH TERRACE**
14 **NORTH, AND BRENNA LANE; PROVIDING AN EFFECTIVE DATE;**

18 **WHEREAS**, the City Council of the City of Palm Beach Gardens, Florida adopted a
19 Budget for the 2013/2014 Fiscal Year; and

21 **WHEREAS**, the City Manager, pursuant to Section 2-293. Appropriations., Code of
22 Ordinance, has authorized the transfer of a not-to-exceed amount of One Million Five
23 Hundred Forty-Five Thousand Thirteen Dollars and No Cents (\$1,545,013.00), subject to
24 approval by the City Council; and

26 **WHEREAS**, the City Council deems approval of this Resolution to be in the best
27 interest of the health, safety, and welfare of the residents and citizens of the City of Palm
28 Beach Gardens and the public at large.

31 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY**

37 Appropriations., Code of Ordinances, a transfer from the Budget Stabilization Reserve to
38 make certain water and street improvements to Sunset Drive, 40th Terrace North, and
